HAUL OUT 2025 - INFORMATION YOU SHOULD KNOW

HAUL-OUT NOTICE – Saturday, October 25 at 8:00 AM SHARP

1. Accounts in Arrears

Members with outstanding balances will not be permitted to haul out. Please settle your accounts in advance.

2. Mast Racks

Because of limited space on the mast racks, members are requested to **strategically place their mast** such that space is maximized. Each rack can hold two masts side by side. Please do not leave gaps between masts. The racks near the ground can be used. Shorter mast should be placed on the racks near the garden shed if space is still available.

2. Crane Setup

We will have **two cranes** this year:

- One in the back lot
- One in the **front parking lot**

3. Arrival Time

If your boat is scheduled to be lifted early, ensure you are on site and fully ready **before 8:00 AM**.

4. Trailered Boats (Not Stored at Club)

These vessels will be hauled out **first** and must be **removed from the parking lot immediately**.

5. Parking Restrictions

- No parking on club grounds until both cranes have finished and departed.
- **Do not park on bike paths** or obstruct street traffic. Be mindful and respectful of neighbors and public pathways.

6. Preparation for Efficient Haul-Out

To save crane time and ensure a smooth process:

- Attach tag lines (bow and stern) at least 20 feet long
- **Test your motor** beforehand to ensure it runs
- Clearly **mark lift points** along the rail, visible from the deck for the crew to properly locate the lift slings
- **Be ready in the queue** when it's your turn
- Ensure **cradle pads** are positioned correctly
- If the lift crew deems you unprepared, you may be charged for delays

7. Hull Washing

For safety and crew comfort, **do not power wash** your hull until your boat is completely clear of others and all spray risk is eliminated.

8. Help New Members

Please offer assistance to new members where needed.

9. Safety Reminders

- Stay out of restricted areas unless authorized
- Never walk under a suspended boat
